Is-Servizz huwa moghti minn tim li bhalissa huwa maghmul minn sitta min-nies: **Andrew Azzopardi** (Service Area Leader), **Antoinette Buttigieg**, **Janette Scicluna**, **Fleur Briffa**, u **Andrew Francalanza** (Social Workers), u **Ronald Balzan** (Administrative Support Worker) li jinsabu gewwa Centru Hidma Socjali St.Venera u numri tat-telefons huma 2144 1273, 21442121.

Is-Servizz jahdem sabiex ikun hemm drittijiet indaqs ghal kulhadd u sabiex ikun hemm partecipazzjoni akbar min-naha ta' persuni b'dizabilita' fil-komunita', biex b'hekk ikun hemm zvilupp u uzu kemm jista' jkun shih tal-abilitajiet u l-potenzjal ta' dawn il-persuni li s-Servizz jahdem maghhom. Sa mill-bidu tieghu, is-Servizz dejjem stinka biex jahdem fuq numru ta' valuri. Valur importanti huwa l-gharfien tal-fatt li l-parti kbira tal-ostakoli li persuni b'dizabilita' u l-familji taghhom jigu wicc'imbwicc maghhom, mhux gejjin mil-fatt li persuna ma' tistax tuza saqajha biex timxi, per eżempju, izda minhabba l-fatt li s-socjeta', hafna drabi ma' toffrix ambjent accessibli bizzzejjed ghall-persuni li juzaw 'wheelchair'.

Is-Servizz jaghti importanza kbira lix-xewqat partikulari u individwali tal-persuni b'dizabilita' li jigu f'kuntatt mieghu, sabiex is-sapport li jinghata ikun verament riflessjoni ta' dawn ix-xewqat. Is- 'social workers' jahdmu man-nies u mhux ghalihom, billi jheggu lill-persuni b'dizabilita' u l-familji taghhom biex ikunu attivi b'mod shih huma wkoll fil-hidma li tkun qed issir dwar id-diffikultajiet taghhom. Fil-hidma, ir-rispett u d-dinjita' lejn il-persuna f'kull sitwazzjoni huma mweghda b'mod assolut. Il-haddiema fi hdan is-Servizz, jitolqu bil-hsieb li tezisti soluzzjoni ghad-diffikultajiet tal-persuna li tkun qed titlob is-sapport, u jaghmlu l-almu taghhom kollu biex bi kreattivita', jaslu ghal dawn is-soluzzjonijiet. Il-barrieri li tqajjem is-socjeta' fil-konfront ta' persuni b'dizabilita', huma varji u mifruxa fuq kull qasam tal-hajja. Ghalhekk, matul is-snin li fihom is-Servizz ilu jahdem, iltaqa' ma' diversi bzonnijiet ta' individwi u ta' familji. Bhala eżempji ta' dawn insibu bzonn ta' informazzjoni u kuntatti ma' servizzi, bzonn ta' sapport minhabba nuqqas ta' access, diffikultajiet minhabba nuqqas ta' sapport mill-familja, diffikultajiet finanzjarji, diffikultajiet gejjin minn xi forma ta' abbuz, u anke diffikultajiet li ghandhom x'jaqsmu ma' diffikultajiet ta' access ghal xoghol jew edukazzjoni. Minn kemm ilu mwaqqaf, is-Servizz hadem ma' madwar **1600** persuna/familja differenti. F'xahar, is-social workers fi hdan it-tim jahdmu ma' bejn wiehed u iehor **230** persuna b'dizabilita' differenti. F'xahar, is-Servizz ikollu madwar **38** talba ghal sapport. Dawn jinkludu kemm persuni jew familji godda, u anke persuni li jkunu diga' ircevev servizz pero' ihossu l-bzonn li jergghu jitolbu ghall-ghajnuna.

X’INHI ‘INDIPENDENZA’ – ta’ Clifford Portelli Kulhadd ghandu percezzjoni differenti ta’ xi tfisser il-kelma ‘indipendenza’. Meta nitkellmu fuq indipendenza fil-qasam tad-dizabilita’ inkunu qeghdin nitkellmu fuq socjeta’ li tkun hielsa minn ostakli w pregudizzji. B’hekk persuni b’dizabilita’ jkunu jistghu jakkwistaw l-abilita’ li jghixu hajja indipendenti u cioe’ kif jixtiequ huma. Agenzija SAPPORT tahdem biex tintegra persuni b’dizabilita’ fis-socjeta’ u biex ikunu indipendenti f’dak li jixtiequ. L-indipendenza ghall-persuni b’dizabilita’ tista tkun fizika, verbali, kif ukoll mentali.

- indipendenza verbali hija meta persuna tkun tista tistaqsi biex iiru l-affarijiet ghaliha.
- Indipendenza fizika hija meta persuna tkun tista twettaq dak li tixtieq personalment jew permezz ta’ accessorji biex jghinuha f’dan. Tfisser ukoll li persuna b’dizabilita’ ikollha access ghall-ispazju ta’ madwarha.
- Indipendenza mentali hija meta persuna b’dizabilita’ thossha mentalment libera li tghix hajjitha kif tixtieq.

Sabiex l-Agenzija **SAPPORT** tkompli toffri u ttejjeb is-servizzi taghha ghal persuni b’dizabilita’, l-ghan ewlieni ghandu jibqa il-kwalita’ tas-servizzi. Biex tinzamm il-kwalita’ tas-servizzi, u bhalma qiegħed isir diga’, xogħol li jsir direttament mall-klijenti ghandu jibqa jesperjenzah kull persuna li tibda tahdem ma’ Agenzija bhal din. Aktar attenzjoni ghandha tinghata lis-servizzi fil-komunita’ b’tali mod fejn dawn isiru aktar flessibbli. Mod ta’ kif il-klijenti li l-Agenzija ghandha fil-komunita’ jistghu isiru aktar indipendenti hua dak imsejjah ‘*direct payment*’, fejn il-persuna b’dizabilita’ tixtri hija stess is-servizzi li ghandha bzonn. Hawn Malta tezisti diga’ dik li nghidulha ‘*carer’s pension*’. Din tista tigi emendata b’tali mod fejn il-fondi jigu indirizzati lil persuna b’dizabilita’ u din tkun tista tixtri is-servizzi tal-carer taghha hija stess u taghzel lil min trid hi. Il-fondi jigu allokati wara li l-persuna b’dizabilita’ tigi assessjata minn *social worker*, *occupational therapist* u persuni ohra skond il-kaz. Il-fondi jigu allokati skond il-bzonnijiet li jkollha bzonn il-persuna biex tikseb l-indipendenza taghha. Barra minn hekk kull persuna tieghu flus kemm ikollha bzonn – la inqas u l-anqas aktar.

Li wiehed ihoss sens ta' sigurta' (**safety**). Meta wiehed ikun familjari ma' l-ambjent li jghix fih, awtomatikament ihossu safe kif ukoll ihoss sens ta' kontroll.

Li wiehed ikun liberu li jespjmi ruhu, kif irid, x'hin irid u ma min irid. Dan nghidulu l-ispazzju tieghek – '**personal space**'.

Il-privatezza. Din ukoll hija tip iehor ta' spazzju personali ta' kull bniedem. Il-privatezza tista tkun li tista toqghod wahdek u taghmel l-affarijiet personali tieghek kif ukoll li tkun tista taghmel affarijiet ohra ma membri tal-amilja fuq livell privat bal perezempju xi glieda li tinqala bejn il-familjari.
